have Granted, Sold and Conveyed, and by these presents do Grant, Sell and Convey unto the said

of the County of Bexar , State of Texas, all that certain tract or parcel of land situated in Nacogdoches County, Texas, a part of the M. Sacco Grant, A-49, and more particularly described as follows:

BEGINNING at the Northeast corner of the said Sacco League and the Southeast corner of the Juan Tobar League on the Western boundary line of the Manuel de los Santos Coy Grant of land the original corner was relocated by witness trees and remains of stump of witness tree (a Water Oak) and a one inch Iron pipe was driven in the ground to remark this important land mark, a Rock was buried in the stump hole, of the Water Oak that had been used as witness tree; This corner being relocated the same was witnessed by two new witness trees, one a 7 inch Maple tree bearing S 86 W a distance of 18 feet and 8 inches and another a ten inch Hickory tree bearing S 10 W a distance of 21 feet these witness trees marked //X//;

THENCE West crossing Cany Bayou three times, the first time at 277 feet and 7 inches, the Second time at 727 feet and the third time at 907 feet pass George Whitaker corner on the Northern boundary line of the Sacco League at 2084 feet on to Russell corner at 4204 pass said corner and at 4491.6 feet, a one inch iron pipe stake was driven for corner from which a Stooped Post Oak tree 15 inches in dia. brs N 21-1/2 W a distance of 8 feet and 2 inches and a Sweet Gum tree 9 inches in dia. brs S 76 W a dist. of 32 feet 2 inches and a three inch Red Oak Sappling brs S 13 W a distance of 13 feet and five inches; (branch about 100 yrd West);

THENCE South crossing the head of a branch at 975 feet and at 2325.9 feet a one inch iron pipe stake was driven for corner, West of a lane, from which a Hickory tree brs N 47-1/2 W 43 feet and 10 inches dist. and a 5 inch Black Jack tree brs N 10-1/2 E a distance of 40 feet and three inches and a 2-1/2 inch Post Oak Sappling brs N 70-1/4 E a distance of 50 feet and 4 inches (at this corner was found old stump holes at proper distance and angles such that they might be remains of trees that once witnessed this corner, no other evidence found);

THENCE East crossing a branch at 332.1 feet, course Southwardly and crossing a wire fence at 4146.1 feet and passing a corner of Blount Estate at the same distance, marked siad corner with 1/2 inch iron pipe under the fence, found old Pine tree with old X mark on same, which tree brs S 42 W a distance of 16 feet and 6 inches, fence brs S 21-1/2 E and on to corner at 4459.1 feet, found wooden stake for corner in place properly witnessed by three Sweet Gum Trees; This line had been properly marked by some surveyor;

THENCE North 3 degrees 5 minutes East (by deed call North) 586.9 feet to one inch iron pipe stake for corner in a field, supposed to have been marked by a wagon thimble, found Red Oak Tree properly marked as described by surveyor munsel (This Red Oak tree about 20 inch dia. brs S 57-1/2 W dist. 133.3 feet) from this corner as reestablished bears witness a Sweet Gum tree 6 inches in

diameter N 67-1/2 W 149.3 feet distance;

THENCE North with the Western boundary line of the Manuel de los Santos Coy League of Land 1755.7 feet to the place of BEGINNING, and containing 240.6 acres of land.

Also, a 50 foot right of way for ingress and egress to the above described land across a 172.7 acre tract this day set aside to H. T. Burk et al and more particularly described as follows:

BEGINNING at a point in the WBL of said 172.7 acre tract at a point 900

feet North of its said SWC;

THENCE East and parallel with the SBL of said 172.7 acre tract 2,753.9 feet to corner in the EBL of said 172.7 acres;
